FEES

A cashier's check, money order, VISA, MasterCard, AMEX or cash must accompany this application. **Checks on commercial or personal accounts will not be accepted during the week of the event, July 19 - 25, 2010. Cancellations are subject to a \$1,000.00 Non refundable deposit.**

1. YAMAHA MARKETPLACE, TRAILERS AND EXPO SPACE

A. YAMAHA MARKETPLACE

SCRAMP will provide the space requested with a canopy, 4 walls, Astroturf, (does not apply to trailer space) for spaces 20' x 40' or smaller. *Expo display space requires additional cost for Tent & Astroturf.*

B. TRAILERS

SCRAMP will provide the space for trailers based on the dimensions requested by the exhibitor. Any exhibitor exceeding the amount written shall have their rental space charge increased accordingly or their space revoked and there will be **NO REFUNDS ISSUED. No person is permitted to stand/sit on top of your trailer in the Yamaha Marketplace**

C. EXPO DISPLAY AREA ONLY

Exhibitor shall not sell or deliver any product(s) or service(s) from the Expo area. The Expo area is strictly for display purposes. **Absolutely NO MERCHANDISE CAN BE SOLD AND DELIVERED AT THE EVENT WITHOUT PRIOR WRITTEN APPROVAL.** Orders for future deliveries are permitted from all exhibitors. No handouts, free samples or solicitation of opinion can be conducted outside of the space rented. (SCRAMP in its sole discretion requires exhibitor's tents to be installed and removed by a SCRAMP approved exhibitor).

2. CREDENTIALS AND PARKING

SCRAMP will provide a maximum of six (6) worker passes (general admission) and two (2) vehicle passes. Any additional worker passes must be purchased prior to the event weekend.

EXHIBITOR AGREES TO KEEP ALL VEHICLES OUT OF THE EXHIBITOR AREA BETWEEN 8:00AM AND 5:00PM EACH DAY. SCRAMP officials with golf carts will be available to assist in bringing in supplies.

3. EXHIBITOR SPECIFICATIONS AND REQUIREMENTS

A. ASSIGNMENT AND LOCATION

Assignments and space location shall be at the discretion of the SCRAMP Sales & Marketing staff and the Director of Exhibitor Services. Assignments to a particular space in the past does not guarantee the same assignment in the future. Exhibitor location will be based on receipt of contract, full payment, resale permit number and certificate of insurance.

B. SET UP AND MOVE OUT

Set-up may begin **TUESDAY, JULY 20, 2010** at 9:00AM. All set-ups must be completed by **FRIDAY, JULY 23, 2010 at 8:00AM. Moveout by MONDAY, JULY 26, 2010 at 12:00PM.** On site labor will not be available. Exhibitor shall arrange for its own labor and shall comply with all regulations set forth by SCRAMP, unions and/or local labor laws. Exhibitor assumes all liability for the shipping, installation and dismantling of his/her display.

C. SHOW DATES

The event will operate from 8:00AM– 5:00PM Friday, Saturday and Sunday, **JULY 23 - 25, 2010.** If exhibitor is not in operation at 8:00AM of each day of the event the exhibitor may be subject to cancellation of future space privileges. **AT LEAST ONE PERSON MUST BE IN THE EXHIBITOR'S RENTED SPACE DURING OPERATIONS HOURS EACH DAY.** No vehicles or storage will be permitted behind or outside of your designated area.

4. EQUIPMENT AND PERSONNEL

A. DISPLAY AND EQUIPMENT

All exhibitors' display and equipment must remain completely within the confines of the space provided during event operation hours each day. **VIOLATORS EXTENDING OUTSIDE OF THEIR SPACE SHALL HAVE THEIR RENTAL SPACE REVOKED AND THERE WILL BE NO REFUNDS ISSUED.** Exhibitors are prohibited from storing inventory or garbage anywhere outside of their space. Exhibitors shall leave their back and sidewalls intact during operating hours. **BANNERS & BALLOONS ABOVE TENT ARE PROHIBITED WITHOUT PRIOR WRITTEN CONSENT. NO SIGNAGE SHALL BE DISPLAYED ON ANY SIDE WALLS OR BACKS OF TENTS.**

B. DAMAGES

Exhibitors shall not damage the park or SCRAMP facilities. Any such damage will be charged to exhibitor and may result in expulsion from the park and exclusion from future events.

C. MOTORCYCLES ON DISPLAY

Please adhere to the following Salinas Rural Fire District guidelines:

1. **Batteries:** Batteries shall be disconnected in an approved manner. (Section 2505.2.2)
2. **Fueling:** Vehicles or equipment shall not be fueled or defueled within in the display area. (Section 2505.2.3.1)
3. **Quantity Limit:** Fuel in the fuel tank shall not exceed one quarter of the tank capacity or 5 gallons whichever is less (Section 2505.2.3.2)
4. **Inspection:** Fuel system shall be inspected for leaks. (Section 2505.2.3.3)
5. **Closure:** Fuel-tank openings shall be locked and sealed to prevent the escape of vapors (Section 2505.2.3.4)
6. **Location:** The location of vehicles or equipment shall not obstruct or block means of egress. (Section 2505.2.4)
7. **Violation:** If in violation of the above, a \$1,000.00 fine will be issued to Vendor.

ADDITIONAL TERMS AND CONDITIONS OF EXHIBITOR AGREEMENT

5. POWER

There are limited spaces available with an electrical hook-up of 20 AMP / 110 Volt outlet. All electrical spaces are on a first-come first-serve basis. If you require more than 110 Volts or 20 amps please order on page 10 (**additional fees will apply**). SCRAMP is not responsible for electrical outages beyond our control. Any other electrical needs in any other spaces are the responsibility of the exhibitor, including: power strips and extension cords (up to 100' in length). All orders due **July 2, 2010**.

6. TABLES AND/OR CHAIRS

Tables and/or chairs are the responsibility of the exhibitor. A limited number of tables and chairs will be available for rent in advance. **There will be NO tables or chairs available for rent on-site.**

7. PHONE, FAX AND INTERNET

SCRAMP offers Phone, Fax, and Internet Connectivity for all events. A communications service order form is available upon request. All orders due **July 2, 2010**. Late orders are subject to a 40% surcharge. Special services and network configurations are also available if your needs are not represented in the requested form.

8. INFRINGEMENTS

All exhibits to be displayed and products to be sold must be listed on this application, as well as the selling price of each item. **Exhibitor agrees not to sell, display or give away any of the following: gasoline/racing fuel, beverages of any kind, or any items containing any part of the event title and event date or the words Mazda Raceway Laguna Seca. All merchandise must be licensed.** Exhibitor shall provide upon demand, written evidence in a form satisfactory to Dorna and SCRAMP in its absolute discretion, that all goods or services that are sold or offered for sale under or with a trademark, brand name or brand logo or other commercial name or logo other than those belonging to the person or organization offering such goods or services for sale, are being sold with the express authority of the person(s) or companies that have full rights (in so far as can be reasonably ascertained) to such trademark, brand name, brand logo, commercial name or logo referred to. In the event that Dorna and/or SCRAMP shall not be satisfied by the evidence produced or in the event that the person or company concerned fails for any reason to produce such evidence in compliance with this clause, Dorna and/or SCRAMP will require that the relevant goods or services be withdrawn from sale immediately and removed from the Circuit forthwith and without limiting the foregoing. Exhibitor warrants its products to be of a pleasing and safe nature and its sale or display is in accordance with the laws of California. **Exhibitor agrees to hold harmless the Sports Car Racing Association of the Monterey Peninsula; the County of Monterey, its officers, agents and employees; and Mazda Motor of America, Inc., d.b.a. Mazda North American Operations, its parent, subsidiary or affiliated companies, or their officers, directors and employees; Dorna, its parent, subsidiary or affiliated companies, or their officers, directors and employees from all claims arising from injury or damage by exhibitor or exhibitor's products.**

A. T-SHIRTS & HAT SALES

No merchandise shall infringe on the trademark, trade name, service mark, service name, copyright or other proprietary right. This includes not having text or logos with the event title, Laguna Seca, Mazda Raceway Laguna Seca, event date, FIM, Dorna or MotoGP and MotoGP rider's images on T-shirt or hat without prior written approval. Suggested retail price

for T-shirts \$20.00. No sale merchandise to be sold during the event.

9. RESTRICTIONS

A. NOISE

Exhibitor agrees not to create or emit any unduly loud or unreasonable noise in demonstrating its products or for any other purpose.

B. CAMPING

No overnight camping will be allowed in the Exhibitor areas. NO EXCEPTIONS! The Exhibitor areas will be closed from 7:00PM until 6:00AM. Security will canvas the area and ask all non-security and all non-SCRAMP officials to leave the exhibitor areas at that time.

C. GIVEAWAYS

Exhibitor shall not giveaway or handout any t-shirt(s) or hat(s) during the event. NO EXCEPTIONS! Any violation may result in confiscation of product(s), expulsion from the park, exclusion from future events and forfeiture of all fees paid.

10. CONDITION

All display areas shall be kept neat and orderly at all times and supplies and other such items shall be kept under cover. On move out date, **JULY 26, 2010** the display area shall be returned to the condition in which it was received. Your company is responsible for placing all waste (boxes folded) in designated trash receptacles. Do not place them behind your tent.

11. ASSIGN, SUBLET OR SHARE

Exhibitor shall not assign, sublet, share or apportion the whole or any part of the rented space allotted without the prior written consent of SCRAMP. Any violation may result in expulsion from the park, exclusion from future events and forfeiture of all fees paid. If SCRAMP approves request, the exhibitor must operate under one resale permit.

12. INSURANCE

Exhibitor insurance must match exhibitor name. Exhibitor shall pay and provide a certificate of liability insurance naming **County of Monterey, its officers, agents and employees; SCRAMP its officers, agents and employees; and Mazda Motor of America, Inc., d.b.a. Mazda North American Operations, its parent, subsidiary or affiliated companies, or their officers, directors and employees; Dorna Sports S.L., International Events Services, S.L., FIM (Fédération Internationale de Motocyclisme), IRTA (International Road Racing Team Association), Promotor Special Events Worldwide S.L., Teams, Service Companies National and International Officials, Race Direction, Clerks of the Course, Sporting Technical Stewards, Timekeepers, Marshals, All VIP guests from the above mentioned bodies, All other interested parties for their respective rights and interest, national Motorcycle Federation its parent, subsidiary or affiliated companies, or their officers, directors and employees as additional insured's, prior to the execution of this contract.**

13. COMPLIANCE WITH LAW

Exhibitor will be responsible for all State and County laws. Your company will be responsible for obtaining a valid California resale number prior to submitting this contract. Law requires verification of a seller's status. Your company must provide evidence of permit. 14. RISK OF LOSS

A. DAMAGES

Exhibitor assumes all risk of loss or damage to exhibitor's merchandise, equipment, fixtures and property from any cause whatsoever. Roving evening security will be provided for the Exhibitor area beginning TUESDAY, JUNE 29, 2010 AT 7:00pm. You are responsible for securing your area prior to

leaving each evening. To order designated security for your booth, the price is \$28.00 per hour/4 hour minimum (rate subject to change). Please contact the SCRAMP office for more details. SCRAMP in its sole discretion requires exhibitors to contact SCRAMP approved security company vendor.

B. NO GUARANTY OF PROFIT

SCRAMP makes no guarantees that exhibitor will make a profit or any monies whatsoever as a result of its activities at Mazda Raceway Laguna Seca. Before completing this application exhibitors are urged to consider a variety of factors, including weather, traffic, location and whether the type of products being offered will be attractive and desirable to the racing public. All financial loss will be born by the exhibitor and no such loss shall be the basis of refund of fees paid to SCRAMP.

15. DISPUTE RESOLUTION/LEGAL FEES

Any dispute between the parties shall be resolved by binding neutral arbitration before a neutral arbitrator mutually selected by the parties. If unable to agree on an arbitrator, the presiding judge of Monterey County shall appoint one. The decision of the arbitrator shall be final. The prevailing party shall be entitled to recover attorney fees. All arbitrations shall be held in Monterey County, California where this contract was performed and executed and shall be the exclusive venue for resolution of all disputes.

In the event that an exhibitor does not conform to the terms of this agreement, SCRAMP's Directors, Assistant Directors and Staff have the right to remove the exhibitor from Mazda Raceway Laguna Seca. All costs associated with removal will be born by the exhibitor. No refunds will be issued if the exhibitor is asked to leave.

The undersigned warrants that exhibitor has read, understands, received a copy of this agreement and will abide by the terms and conditions in this agreement and has the authority to contract on behalf of the exhibitor. Any breach of this agreement by the exhibitor shall be at the sole discretion of SCRAMP, exclusion from future racing events and exhibitor shall be liable for all damages.
